FRESH SPERM

Reception of **3 straws per transport.**
 With a maximum of 9 straws for the season.
 Milton Z usually fills with 1 straw/insemination.
 Used straws should be sent to the seller.

FROZEN SPERM

- The breeding price only includes the price of doses. Transport is the responsibility of the buyer + TRACES certificate.
- Unused doses remain the property of Of Heritage Stud LTD and must be returned to the seller.
- Setup costs, boarding costs and gynecological follow-up costs are the responsibility of the buyer.
- Only one mare can be inseminated per covering contract. The mare can be inseminated as many times as necessary with fresh semen as long as the stallion is available. When frozen, a maximum of 9 straws will be sent.
- Sending 3 additional straws, only if the previous ones are sent back at the address from which they were sent.
- The breeder must send a copy of the mare's passport to be able to issue the breeding certificate.
- If the mare is sold before the birth of the foal, the terms of the contract remain applicable to the buyer. The breeding certificate will be given to him.
- The reservation of the covering is effective upon return of the signed contract and receipt of payment for the reservation. The signatory of this contract is legally liable for payment of the breeding.
- Any fraudulent use of semen will be subject to prosecution. Registration of the foal in a studbook without payment of the covering is considered fraud. Any fraud will be punished with a fine of €5,000.
- Any dispute directly or indirectly relating to our contractual relations with the buyer falls under the exclusive jurisdiction of the Courts and Tribunals of the district in which the seller is located.
- The buyer certifies having read all of our General Terms and Conditions available on our website, in our catalog or on the invoice sent.
- This contract is valid from receipt of payment/receipt of checks.
- Of Heritage Stud LTD cannot be held responsible for any problems occurring when sending the semen by a transport company. If there is a problem, the customer must notify us on the expected delivery date.

SALE CONDITIONS

The buyer purchases a breeding straw for the stallion Milton Z for the mare mentioned under the following conditions:

- €300 (excluding VAT) deposit upon booking. Non-refundable - cannot be transferred to another mare in 2025.
- €1,500 (excluding VAT) balance on 10/01/2024 if pregnant mare.

Live foal guarantee 48 hours.

Only a veterinary certificate of non-pregnancy as of 01/10/2024 will cancel the invoice of 01/10/2024.
 Only a veterinary certificate of abortion or viability of the foal at 48 hours will result in the postponement to 2025.
